Directions to ORU Aerobic Center - 2631 E. 81st St. 74171

Turn north on University Drive east of Lewis and immediately enter the lot on your right before the guard shack; park and walk east along the long walkway leading up the hill to the aerobic center. If you are only dropping off, feel free to take the road to the right just past the guard shack and stop along the sidewalk leading up the hill on your right before you cross the bridge about 500' past the guard shack; there is also a lot on the left here. *If access to a closer door is required at ORU due to limited mobility, contact Darin to access the security gate in the SE corner of the parking lot; contact info is available below on this pool sheet.*

Pool Info

- Coaches' CHECK-IN—30 minutes before playing. Captains of first match will be called 10 minutes prior to play.
- The pool will play only two sets against each opponent; **sets will start at 4-4** and have no cap.
- Warm-ups will be 4-4 for the first match and 3-3 for later matches. Serve within your time. No shared back court.
- R-1(up official will be provided) while teams will provide R-2, Score/Flip, Libero Tracker, and 2 Line Judges
 - Have your team ready to officiate at the conclusion of the previous match; report to the R1 official.

Tie Breaker Process

Two-Way Tie Breaker Process

- Consider 1st – Head to Head Sets
- Consider 2nd – Head to Head Points
- Consider 3rd – Overall Point Differential
- Consider 4th – coin flip

For advancement – If still tied after head to head points, play one set to 15.

Three-Way Tie Breaker Process

- Consider 1st – Overall Point Differential
- Consider 2nd – One set to 15, bye determined by coin flip if all three teams are still tied on OPD

For advancement – Top team is determined by OPD and then coin flip. Remaining two teams then play one set to 15.

Bracket Play

The **top four teams in each pool will advance** to bracket play. 1st and 2nd advance to gold while 3rd and 4th advance to silver. Teams finishing 5th will be finished after pool play; no officiating in bracket is required. Medals will be awarded for 1st and 2nd in gold and 1st only in silver. Teams will play 2/3 with no cap on any match, but the 3rd set, if necessary, will be to 15, and teams will switch sides at 8.

Warm-up balls will NOT be provided. There should NOT be volleyballs outside of the gym floor area.
